his is the fourth newsletter of the Valorize Non Formal and Informal Learning (NFIL) project in the framework of the Erasmus+ Strategy partnerships programme.

NFIL advances well on the completion of the project intellectual outputs and prepares for the experimentation and model validation activities with potential beneficiaries in all countries that are represented in the project.

The fifth partner meeting took place on **September 25th, 2019 in Varna, Bulgaria**. It was hosted by the International Management Institute.

The discussions started with an overview of the final draft of IO2 “Transnational Framework of verifiable and certifiable competences” and the functional version of IO3 “Computer Database Processing”.

The **Transnational Framework of Verifiable and Certifiable Competences** is designed according to the VET and qualification systems of the countries represented in the project – namely Italy, Bulgaria, Spain, United Kingdom, France, Slovenia and Belgium. Given the scope and time-frame of the project, the framework was not designed to cover all professional areas, but rather to create and test a prototype that works for an exemplary group of professionals and that can be upgraded with time. The organisational logic of the framework follows the common European and international standards for classification of economic activities, occupational profiles and qualifications and thus allows for extension and accommodation of other sectors and countries in real terms beyond the project.

Thus, the framework initially contains an overview selection of 140 qualifications (qualification profiles) - 20 for each of the countries represented in NFIL and relevant to 20 occupational profiles in trade, catering and hotel, ICT and social health fields - defined with their

- Relevance to a sector of economic activity,
- Relevance to a professional profile (job, occupation),

- Country,
- Required qualification (for the specific country) with its NQF and EQF levels,
- Core competences,
- Forms and procedures for obtaining the required qualification,

as well as other key elements defined by the relevant national regulations.

The **Computer Database Processing** is the on-line tool and repository of the information presented in the framework: <https://valorizenfil.dedi.velay.greta.fr>.

The partners decided to add **4 new professional profiles in the database** in order to verify and sustain its functionality. These are:

- Creative and performing artists
- Agricultural technicians
- Hairdressers, beauticians and related workers
- Building finishers and related trades workers

The partner meeting in Varna ended with a detailed overview of the draft of IO4 that contains **detailed modalities to involve and guide migrants and other beneficiaries interested in validation of NFIL through a 7-steps path**. Following this the mobilization of the local stakeholders is considered for the testing and experimentation phases of the projects that follow.
